

## DIRECTIONS TO FORENSIC SERVICES AND CORONERS COMPLEX (FSCC) AND VISITOR PARKING INFORMATION

### Location

The Forensic Services and Coroners Complex (FSCC) is located on Morton Shulman Avenue. The closest main intersection is Wilson and Keele. Please see map below for further clarification.



### Directions

From the 401 Westbound – exit to Keele Street and proceed through the lights onto Sir William Hearst Avenue.

From the 401 Eastbound – exit to Keele Street North turning left at the first lights onto Sir William Hearst Avenue.

From Wilson Avenue access can be obtained from either Petherhill Avenue or Morton Shulman Ave. on the south side of Wilson Avenue west of Keele Street.

## Parking Costs

The FSCC visitors utilizing Parking Lot A will be required to pay hourly/daily parking charges as follows:

Lost tickets will be charged a minimum of \$33		

## Visitor Parking

A maximum number of 50 parking spaces will be available for visitors to the Forensic Services and Coroners Complex. These spaces are located in Parking Lot A which is directly south of the FSCC on Sir William Hearst Avenue (please see map). The following outlines the Parking procedures for FSCC visitors:

- Unit Park will provide FSCC Contact with a parking access code

The code for FSCC Visitors in lot A is **1670 followed by the star (\*) button**  
**Effective: June 1st, 2024**

- At Parking Lot A please disregard the “FULL” parking sign and enter the correct parking access code # on keypad to activate Entry Station and obtain an electronic ticket
- Press “HELP” button at any time for assistance.
- Park your vehicle in a non-designated parking space and proceed to the FSCC building on the north side of Sir William Hearst Avenue.
- Upon your return to parking lot A, you will have two options to pay for your parking ticket:

### **Option 1**

- Proceed to PayStation located in Lot A
- Insert electronic ticket into PayStation
- Amount due will be displayed on the screen
- Press receipt button if receipt is required

- **Pay with Bills, Coins or Credit Card (MasterCard or Visa only)**
- **Once your payment is complete, remove paid electronic ticket and drive to the exit**
- **Insert the paid electronic ticket in the exit terminal and the exit gate will open.**
- **Press “HELP” button at any time for assistance.**

## **Option 2**

- **Drive to the exit and insert the electronic ticket in the exit terminal**
- **Amount due will be displayed on the screen**
- **Pay with credit card only (MasterCard or Visa)**
- **Receipt will be issued by the exit terminal**
- **Remove receipt for the exit gate to open**
- **Press “HELP” button at any time for assistance.**
